ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, HCITIS ISV OBO ASSOCIAÇÃO PIAUIENSE DE HABILITAÇÃO, REABILITAÇÃO, READAPTAÇÃO (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
